This would mean a student that was required be quarantined due to exposure to COVID-19 could stay in school as long as they tested negative daily. The County stated they cannot obtain enough rapid tests to be able to sustain this program. It was asked if an individual needed their booster shot to be considered fully vaccinated, and the answer is no a booster is not required to be considered fully vaccinated. Next week we will be starting to test our unvaccinated staff per the NYS guidelines. The Federal American Rescue Plan (COVID relief monies) that the school receive will be utilized to find programs to help fill gaps from the COVID pandemic. A product was also discussed for children who have been put into quarantine to help them with the gaps from virtual learning.
