3.1 Ann Hall inquired about HCS Library possibly becoming. Jan reminded the public that this was tried in the past but no one used it. Jan would like to collaborate with public if that is possible.

Karen Dreythaler brought up a concern about paid crowd control to maintain order at soccer games, expressing concern that the crowd may not know why they are being approached by someone other than an administrator. Mr. Merritt explained Section 10 regulation requires this obligation to be met by site supervisors. Administrators intend for these supervisors to wear identifying clothing once it arrives.

Jackie LaPlatney asks about Fall Fun Day; some students may be upset that they can't wear their costumes. Jan says that many parents are happy to not have to come up with costumes. She also mentioned that society is doing away with holiday themed parties in public school. Sue Ward says it is a rite of passage to go in the parade in costume. Dixie Dickinson mentioned that there was an incident in the past with a non-custodial parent coming to class on Halloween putting that student in danger and the school at risk of lawsuit. Dixie also welcomed the public to attend the elementary dance which will allow students in elementary school to come in costume. Mr. Luther discussed traditions are understood but that we are changing demographics and safety is a major concern. Our Fall Harvest Committee has planned out many more activities than was previously practiced in a parade. Harold Hill II offered his service as a private security detail during school functions. Mr. Luther plans to have staff members who know majority of community members for security purposes in the lobby to check identification and hand out identifying passes.

Sandi Moore wants to know if all girls have received their uniforms yet. Mr. Merritt said the uniforms were shipped on 9/30/2014 but company cannot tell us where they are; he is following tracking numbers. Sandi reminded everyone that there may be a similar situation with JV basketball.
