3.0 Public Participation – Mrs. Hall asked about how the American Rescue Plan (ARP) funds are being utilized. Mrs. Hall let the Board know at the Town Board Meeting it was discussed that there is a home in the Town of Pitcairn not fit to live in. She asked if there was a Public Health Officer. Mr. Finster explained if there was an issue the School could call Child Protective Services.

She discussed when she was a Substitute in the building, the 5th and 6th grade hallway was full of clutter from the students. Mr. Luther explained there are new, bigger lockers coming for that hallway.

The possible need for a Self-Contained Room was discussed for our Special Education students.
